Acknowledgment: I acknowledge receipt of one (1) Access Control Card. This card will give you access to the Brookstone I Basketball Court and the Unisex Restroom located at the amenities area at 5595 Hedge Brooke Drive. The electronic access control locks have been installed to help protect your investment, and to limit access to only authorized users of the Association's facilities. **Please do not give your card to anyone else to use. The Association will receive reports from the security company detailing all usage of the cards. Blocking of the gate or door is strictly prohibited, and will result in an alarm sounding. Violations of the Rules & Regulations listed in this Acknowledgment will be dealt with pursuant to the Declaration of Covenants for Brookstone.**

Lost Cards: Each family will initially receive one Access Control Card. The fee to replace lost or stolen cards will be Ten (\$10.00) Dollars per card. Please contact Access Management to immediately report a lost or stolen card. - **Reserved Courts have Priority. You may reserve the Court in advance by using the online reservation website at www.reservemycourt.com. The Court may be reserved for no more than ninety (90) minutes at a time, and the Court reservation will not be valid for more than fifteen (15) minutes after the reserved time if you are not there, and other members wish to use the Court.**
- **This court is for the use of Brookstone 1 Residents, Authorized Users, and a guest.**
- **Profanity, offensive language or behavior is not allowed.**
- **No food or glass containers are allowed inside the Court.**
- **No alcohol or smoking allowed.**
- **Loud music is not permitted.**
- **No bikes, skates or similar items are allowed inside the fenced area of the Court.**
- **Please remove personal items and any trash when leaving.**
- **Anyone caught vandalizing the area will be prosecuted to the fullest extent of the law, and Residents will be subject to fines and damages and the loss of use of the amenities area.**
